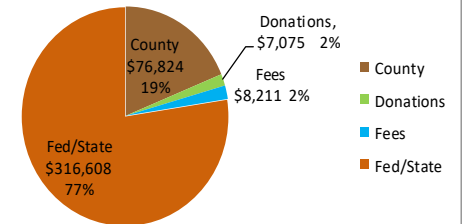
## Our quality past is why we're hopeful for the future!
